### President's Report 2023 -2024

#### Shirley Glance OAM President PPV

Dear Post Polio Victoria Members and friends,

Last year, we finished on a high note with our award-winning documentary in the <u>Focus on Ability Nova Employment Award</u>: We have shared this at every opportunity, speaking with Ministers at the Federal and State Levels, Lions Clubs, Rotary Clubs, Salvation Army, and Probus presentations. The City of Mooney Valley will be holding an event for International Day of People with Disability; PPV will be represented as part of a panel discussion about our documentary.

Reflecting on the year that's been: It has been rather stressful for the NDIS and The Aged Care sectors. The home care sector is included in this, leaving many participants in a state of instability regarding how it will affect them; the changes are not evident for both and are confusing for the consumers and their families. We at PPV are very concerned about these issues. Over the last twelve months, we have attended workshops, roundtable discussions, and conferences in Adelaide, Sydney and Hobert to help us understand how best to assist our members in navigating these issues and by sharing our lived experiences to highlight the needs of polio survivors to have equal access to services we need to live actively and independently.

Post Polio Victoria, attended conferences, meetings with Ministers at both State and Federal levels, and attended workshops and seminars to learn and understand how best to share the changes with our community; however, this is a revolving door and forever changing.

Whilst in Canberra, we had the opportunity to meet with Federal Ministers and advisors to put our case forward regarding the discrimination faced by polio survivors being excluded from the NDIS and not receiving adequate support from the Aged Care services; all we are asking for is quite simply this:

That the NDIS remove 'section 22.'

"The NDIS contains a provision (section 22) banning all disabled people over 65 from eligibility for the NDIS. The scheme was gradually rolled out by date and postcode and completed in 2016.

So, the ban was mainly applied to disabled people 65 years old or over in 2016. The government's slogan seems to be: "Born 52, tickety boo, born before, out the door" Peter Freckleton.

Polio survivors have had their disability, known as "Infantile Paralysis", since childhood, so it has nothing to do with their 65th birthdays, and yet, bizarrely, many have been banned from NDIS support. That is unjust and discriminatory, as government spokespersons have admitted.

This cruel discrimination is contrary to both the official NDIS eligibility lists.

<u>List A: Conditions that are likely to meet the disability requirements</u> [1] and <u>List B: Conditions that are likely to result in a permanent impairment</u> [2]

In List A, the NDIS accepts Item 5, "Spinal cord injury or brain injury resulting in paraplegia, quadriplegia or tetraplegia." Infantile Paralysis as a result of polio falls within that category.

List B includes Post-polio Syndrome explicitly.

Accordingly, we believe that polio survivors have been denied NDIS support far too long and must be exempted from the age ban."

We have been advocating for this for over five years. However, as an organisation, we will not give up on this; we hope that we can look forward to making a breakthrough in the future. We need your support to do this and help us fight for the cause. Currently, there is a Class Action Clarification—Purpose: To end the NDIS ban against people with disabilities over 65 years old. This is still in progress.

Robyn Abrahams and Susan Shaab attended the 57th Australian Association of Gerontology (AAG) Conference in Hobart, which was themed "Fresh Air, Fresh Thinking." Robyn presented at The President's Symposium as part of a panel on "Good Spirit, Good Life." Her presentation was well received, and she had lots of questions afterwards.

Peter Freckleton has taken his case to the UN Age discrimination complaints on the NDIS age cap taken to the United Nations. He is waiting to hear the outcome of this, and we will keep you posted; <u>please see</u> the full article here:

<u>Our strategic plan for 2024-2027</u> was completed during the year, and I would like to thank Robyn Abrahams and Anne Wright for facilitating the process. We had lively discussions focusing on the positive outcome of continuing to advocate, educate, and promote to our members and the wider community the importance of appropriate care for people living with polio/post-polio syndrome for the next three years and beyond.

We have made submissions on behalf of PPV to:

- Submission to the call for inputs on the 2030 Agenda of Sustainability Agenda
- Department of the Senate, in response to the Aged Care Act
- Aged Care Legislative Reform Branch

Individuals have also made personal submissions based on lived experiences, and we thank them for their support.

We are excited to announce that we are now formally aligned with Neurological Alliance Australia NAA and the Australian Federation of Disability Organisation AFDO. This collaboration strengthens our advocacy and amplifies our voice in the community.

Navigating the changes has been challenging. We have worked tirelessly, meeting with many politicians and speaking engagements to spread the word. As a committee, everyone has put in a great effort this year. However, I would like to acknowledge particularly Peter Freckleton and Robyn Abrahams for their unwavering commitment to our advocacy work, Anne Wright for keeping us on our toes with our finances, Susan Shaab for taking the minutes, and Jeff Stewart for taking on the editorship of the newsletters and bulletins, all the above would not have been able to be done without the support of dedicated committee members, Deb Colville, Petra Quinlin-Turner and Geoff Dean who challenge us with questions and help us make important decisions that make an impact on our outcomes.

Also, a big thank you to Carol and Sue for their administrative support.

Thank you to our donors, sponsors, and friends of PPV. Without your financial assistance, none of the above would have been accomplished.

# Who we are

Post Polio Victoria Inc (PPV) is a volunteer-managed and staffed advocacy and information group. It was formed in 2011 and has over 300 members, most of whom are people with polio.

PPV is managed by a Management Committee primarily composed of people with polio. Under its constitution, two-thirds of the Committee, the President, and the Vice President must be people with polio.

PPV's mission is to support people with polio so they can live as fully in the community as possible. There are an estimated over 40,000 people with polio in Australia. It seeks to do so by:

- Through engagement and collaboration with communities, we will advocate for the best outcomes and equal and equitable access for people with polio to enable all to thrive.
- Advocating on behalf of people with polio to levels of government, health institutions and health providers
- Providing information to people with polio concerning the provision of health services, government support and self-help
- Educating and raising awareness amongst health service providers and government about the health and support needs of people with polio

PPV has DGR status. While focused on Victoria, we have connected with polio associations worldwide; we are involved with Polio Australia and liaise with our interstate equivalents and polio support groups in Victoria.

- Submission to the Royal Commission 'Against the Exclusion of Polio Survivors from the NDIS
- Response to the Regulation Impact Statement Consultation Proposal to include minimum accessibility standards for housing in the National Construction Code





Working to ensure we are not discriminated because of age has seen us gain United Nations support for anti-discrimination and we are a major participant in the class actions with Mitrys Lawyers regarding the unlawful discrimination by exclusion of over 65s into the NDIS. We have had many advocacy opportunities and presented at conferences, made short films and won awards for bringing the voice of people with polio to the forefront and can say that PPV is consulted with and an active member across many other chronic disease and advocacy groups.

In our next three years, we will continue our very important advocacy work to ensure our members area represented and receive equitable access to all health care. We will also bolster the education that we provide to our members, ensuring they are have information at hand and know how to best support themselves.

Seeking to promote post-polio syndrome and other chronic diseases to ensure our policy makers and service providers can supply what is needed, and that this is shared amongst those other organisations seeking to ensure equitable health care whom we are affiliated with, whilst working to ensure our sustainability.

### Financial Summary 01 July 2023 - 30 June 2024

PPV has once again had an extraordinarily busy year. As our President Shirley will have reported, conferences, advocacy, affiliations and presentations. Pleasingly, our financial year activity reached higher income than previous years. Donations reached just over seven thousand and of course, the prize money from the Nova film festival hitting our accounts in November resulting in an additional twenty-seven thousand dollars. Our total income for the year reached just over thirty thousand dollars, thanks to our generous sponsors and the hard work of the board, and especially our President.



Our expenditure went largely to running the business and keeping our members up to date with newsletters, bulletins, updated and more accessible website and other communications which can be seen in the administrative fees, and towards our advocacy work which is reflected in the conferences and travel fees.



Overall, we have ended the financial year with a healthy bank balance of \$44,486.96.


